GENERAL INSTRUCTIONS:

- BORON X-Tra is designed as a foliar spray for cotton, vegetables, trees and other crops, which require supplemental Boron. It may also be used as a soil applied product.
- This product has a lower pH level compared to other Boron solutions, which improves its effectiveness as a foliar application.

COMPATIBILITY:

BORON X-Tra mixes well with most spray chemicals, but ALWAYS TEST FOR COMPATIBILITY FIRST.

APPLICATION:

When applying by ground sprayers, use with a minimum of 60 L of water per ha. When used in aerial application use at least 20 L of water per ha.

STORAGE AND DISPOSAL:

Store in the closed, original container in a cool, well-ventilated area. DO NOT store for prolonged periods in direct sunlight. DO NOT store material that has been mixed with water – it will not keep. Triple or preferably pressure rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush, or puncture and bury empty containers in a local authority landfill. If not available bury the containers below 500 mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Empty containers and product should not be burnt.

SAFETY DIRECTIONS:

Wash hands after use. Avoid contact with skin and eyes. DO NOT SWALLOW.

FIRST AID:
