#### **GENERAL INSTRUCTIONS:**

Zinc X-Tra is designed as a foliar spray for cotton, vegetables, trees and other crops, which require supplemental Zinc. It may also be used as a soil applied product or seed dressing.

#### COMPATIBILITY:

Always check physical compatibility before mixing with other products.

#### **APPLICATION:**

For foliar application, when applying by ground sprayers, use with a minimum of 50 L of water per ha. When used in aerial application use at least 20 L of water per ha.

As a seed dressing apply directly to the seed without dilution prior to planting.

Consult Growth Agriculture should more information be required.

#### **STORAGE AND DISPOSAL:**

Store in the closed, original container in a cool, well-ventilated area. DO NOT store for prolonged periods in direct sunlight. DO NOT store material that has been mixed with water – it will not keep. Triple or preferably pressure rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point.
